**DROP OFF Procedures**

**Children's RE:** On Sunday mornings, we would ask that parents to please **sign-in ALL children K- Middle School** on the attendance clipboards at the RE table in the parlor.

**High School Youth Group** students may sign themselves in with parent's knowledge, and proceed to the Youth Group meeting space in the Annex, where teachers will check the list against students present.

**Youth Groups (High School, Middle School)** may proceed to their meeting spaces at **10:30 am. Please do not proceed to classrooms prior to meeting times.**

**Children Program:** Children K through 6th grades will accompany parents in to the Sanctuary, to remain until 'Stories for All Ages' has ended, at which time they will be **dismissed to meet their teachers back at the RE table.** We ask that parents who arrived late, or were otherwise unable to add children to the attendance sheet, please go with them, and sign them in to classroom lists at that time. **Teachers** will pick up attendance sheets, check children present against the sheet, and proceed to classroom spaces. Please, **at no time should ANY CHILD under High School age proceed to RE classroom spaces without an accompanying adult.**

**PICK-UP Procedures**

**Preschool Program** Please pick your child up in the Nursery/Preschool room by **12:00.**

**Children's Program** Please pick your child up at **11:45 in Room 213 (3-6 classroom).**

FUSIT RE programming will run until 11:40, at which time children will proceed **Room 213 with teachers** for conversation, snack and fellowship time. **Middle School students** will be accompanied by teachers to join **High School students** for **Fellowship in the Parlor.**

Teachers will bring attendance sheets to the rooms, to hand to **RE Staff, who** will supervise dismissal. Teachers may then proceed to the parlor for Fellowship. A healthy snack (vegan and non-vegan) will be provided for children at that time (**please inform us if your child has a significant allergy or dietary limitation**).

**Parents will please meet their children at Room 213 for pick up between 11:45 and 11:50 and SIGN OUT** on the attendance sheets provided. Children attending FUSIT RE will **NOT be dismissed to the Parlor space** unaccompanied by an adult.
